## FUND DESCRIPTION

**Investment Objective:** The investment objective of the Horizon Expedition Plus ETF is to seek to provide total return.

The Horizon Expedition Plus ETF seeks total return by investing primarily in large-cap U.S. equity securities and selling and purchasing put and call options in an effort to generate income to the Fund. The Fund employs techniques, including strategic portfolio positioning and security selection, to seek to achieve higher overall volatility as compared to the large-cap equity market generally.

## ASPECTS OF THIS ACTIVE FUND

**Domestic:** Combines large-cap U.S. stocks with a strategic use of option put spreads to enhance return potential.

**Enhanced Equity:** Designed for higher volatility exposure than traditional equity, seeking long-term returns with tactical flexibility.

**Options-based:** Uses options to seek more predictable return profiles while increasing market participation.

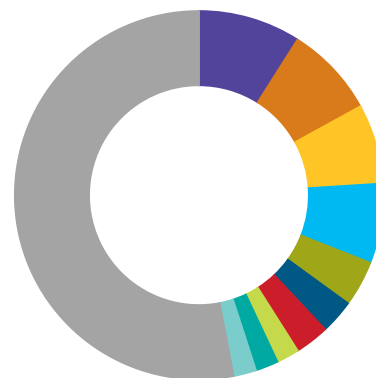
